#### SPONSORSHIP/EXHIBITOR AGREEMENT

Sunday, July 6, 2025, thru Saturday, July 12, 2025

This is an agreement between the Sponsors, Vendors, Exhibitors and Chi Eta Sorority, Incorporated for sponsoring/exhibitor space at the 68th Boulé and Educational Conference of Chi Eta Sorority, Inc. on the dates noted above. Contract terms are as follows:

**PAYMENT**: The booth fee for sponsors/exhibitors is \$900.

**REFUNDS FOR CANCELLATION:** The booth fee (MINUS \$100.00 SERVICE CHARGE) will be refunded if written notice of space cancellation is postmarked by June 6, 2025. **NO REFUNDS WILL BE ISSUED AFTER THIS DATE**. Failure to occupy the space does not release the Sponsor/Exhibitor from obligation to pay for the full cost of space.

**WI-FI ACCESS**: The fee to access Wi-Fi is \$50/day (please note that this is subject to change). The Sponsors/Exhibitors will be responsible for the Wi-Fi fee. If Wi-Fi is needed, please include it with payment.

**STANDARD TABLES:** The standard space furnished will consist of one 6' x 30" table, and two chairs. No constructed display or signage may be placed higher than 10 feet on the back wall of the exhibit area or outside the assigned vending area. Tape, tacks, screws nails or signs cannot be placed on the hotel walls. Any clothing racks to be used must be furnished by the Exhibitor and may not extend beyond the one table space. A second table, at the same price, may be reserved should you need additional space.

**SUBLETTING OF SPACE: Sponsors/Exhibitors** may not assign or sublet any space allotted to them and may not advertise or display goods other than those manufactured or sold by them in the regular course of their business.

**CARE OF SPACE, BUILDING AND EQUIPMENT:** Sponsor/Exhibitors and their agents shall not injure or deface the walls of the building and booths. Sponsor/Exhibitors are forbidden to drive nails, tacks, tape, or screws into the walls, floors, columns or other parts of the building or furniture. Distribution of promotional gummed labels or stickers is prohibited. The Exhibitor is liable to the owner of the property if such damage occurs. All materials used for decorations must be flameproof. Combustible materials or explosives are not allowed in the exhibition area.

**USE OF SPONSOR/EXHIBITOR SPACE:** Each space must be staffed during specified hours. The company's representative/exhibitor must always wear conference badges. Please contact Sheraton New Orleans Hotel directly for hotel specific information, Dawnta Spriggs, Event Planner, (504) 525-2500.

**INDEMNIFICATION CLAUSE:** Sponsors/Exhibitors assume the entire responsibility and liability for loses, damages and claims arising out of injury to persons or damages to Exhibitor's displays, equipment or other property brought upon the premises of Sheraton New Orleans Hotel and agrees to indemnity, defend and hold harmless Chi Eta Phi Sorority, Incorporated and Sheraton New Orleans Hotel and its owners, servants, agents and employees against all claims or expenses for such losses – including reasonable attorney's fees arising out of the use of the hotel premises excluding any liability caused by the negligence of Chi Eta Phi Sorority, Incorporated or Sheraton New Orleans Hotel or its owner(s), servants, agents and employees.

**LIABILITY AND INSURANCE:** The Sponsor/Exhibitor understands that neither Chi Eta Phi Sorority, Incorporated nor Sheraton New Orleans Hotel maintains insurance covering the Exhibitor's property or lost revenue and it is the sole responsibility of the Sponsor/Exhibitor/Exhibitor to obtain such insurance.

The Sponsor/Exhibitor assumes all risk of loss. All goods stored overnight are at your own risk.

RESTRICTIONS IN OPERATION: Chi Eta Phi Sorority, Incorporated reserves the right to restrict or evict vending that the sorority deems objectionable because of noise, method of operation, materials, or any other reason that Chi Eta Phi Sorority, Incorporated believes detracts from the mission of our organization. In the event of restriction or eviction, then Chi Eta Phi Sorority, Incorporated is not liable for any refunds or other expenses. Chi Eta Phi Sorority, Incorporated is a trademark organization. Chi Eta Phi Sorority, Incorporated (CEPS) and its logos and seal/emblem are trademarks of Chi Eta Phi Sorority, Incorporated. YOU MAY NOT USE CHI ETA PHI SORORITY, INCORPORATED'S NAMES OR LOGOS OR ANY VARIATION THEREOF, WITHOUT PRIOR WRITTEN CONSENT OF CHI ETA PHI SORORITY,

**INCORPORATED.** You may not use the CEPS name in any of its forms. Sponsor/Exhibitor may not use Chi Eta Phi Sorority, Incorporated logo or other signs denoting the organization unless appropriate fees have been paid and a contract for use has been obtained from Chi Eta Phi Sorority, Incorporated National office. **RIGHT OF THE CONFERENCE MANAGEMENT:** Should any emergency arise previous to 68th Boulé and Educational Conference of Chi Eta Phi Sorority, Incorporated which would prevent its scheduled opening such as natural disasters, strikes, destruction or damage of the vending area, or damage a declaration of a National emergency, it is expressly understood and agreed that the sorority may retain as much of the booth payment as necessary to cover expenses incurred up to the time of such emergency.

**AMENDMENTS:** Chi Eta Phi Sorority, Incorporated reserves the right to interpret, amend and/or enforce these agreements, conditions, rules and/or regulations. Written notice of any amendments or interpretations shall be given to each Sponsor/Exhibitor/Exhibitor. Each Sponsor/Exhibitor (for himself, his agent and employee) agrees to abide by the agreement/conditions/rules/regulations set forth herein or by any subsequent amendments and interpretations. This agreement must be signed by an authorized representative of the Exhibitor, referred to in this agreement as Exhibitor.

**FULL PAYMENT** of the Sponsor/Exhibitor booth fee is **due on or before June 6, 2025**, and must accompany the completed agreement form. Space assignment will be on a first come, first serve basis. Chi Eta Phi Sorority, Incorporated reserves the right to rearrange the floor plan and may relocate booths.
